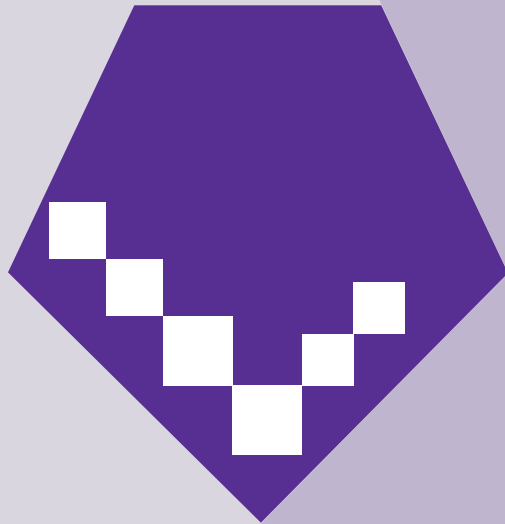

Terms and conditions concerning participation of the National Econometricians Day 2023 (in Dutch: Landelijke Econometristendag 2023, abbreviated as LED 2023)

Landelijk Orgaan der Econometrische Studieverenigingen, abbreviated as LOES, in statutory terms located in Utrecht, will organize the LED 2023 with the following conditions:

A. General

1. The Landelijke Econometristendag 2023 will take place on Thursday February 9, 2023, in a physical setting at the NBC. However, this can change due to circumstances beyond our control. The LOES has the right to change the real life event to an online event.
2. The LOES has the right to cancel the event at any time due to any circumstances beyond its control and without any possible compensation for the participants or anyone else.
3. The LOES cannot be held responsible in any way for any damage that occurs during the event.

B. Participation

4. In order to be considered for participation, students should have received a confirmation mail for participation after subscribing on the subscription platform.
5. In total 780 participants are allowed to participate at the LED 2023. The LOES has the right to increase or decrease this number.
6. Participation is only possible for members of the following associations: Asset | Econometrics, FAECTOR, Krakel, Vectum, VESTING or VSAE.
7. Participation is only possible for students in the fields of econometrics, actuarial sciences or operations research.
8. For students enrolled in a (pre-) master or PhD program in one of the above mentioned fields, subscriptions open on Thursday November 17, 2022, at 20.00 hours.
9. For students enrolled in a bachelor program in one of the above mentioned fields and who have started this program in 2020 or before, subscriptions open on Thursday November 17, 2022, at 20.00 hours.
10. Students who started their bachelor after 2020 cannot participate at the LED 2023.
11. Students who are on the blacklist are excluded from participation at the LED 2023.
12. Selection for the LED 2023 will be based on the time of your subscription. Students who are not selected will not be permitted to the LED 2023. However, when entered to the waiting list procedure a second selection is still possible. This procedure is further discussed in section C2. Discussion or feedback regarding the selection is not possible.
13. Students who subscribe after the maximum number of participants is reached, will be placed on a waiting list.
14. Students who have a secured place at the LED 2023, will receive an information email on Monday January 16, 2023 at the latest.
15. Students who are on the waiting list will be reminded about this on Monday January 9, 2023 at the latest.
16. For students that have secured a place at the LED 2023 is the deadline for submitting preferences regarding companies Sunday December 11, 2022, 23.59 hours.
17. The assignments of the company cases & the speeddates will be communicated to the students personally on Wednesday February 8, 2023 at the latest. Discussion or feedback regarding the assignment is not possible.
18. By applying for the LED 2023, you accept the terms and conditions. No controversy will be taken into consideration.

C1. Obligations participant

19. The participant commits him or herself to pay the participation fee of €7,50.
20. The participation fee only needs to be paid in case the student is selected for participation.

21. Cancellation of participation at the LED 2023 without any valid reason is possible until Sunday December 11, 2022 23.59 hours. The participant will not receive the full amount of €7,50, as €0,99 of the fee is non-refundable.
22. Cancellation of participation at the LED 2023 without any valid reason after Sunday December 11, 2022 will result in a fine of €50,-, in words fifty euro. In addition to the fine, the participation fee will be charged and the student will be placed on the blacklist. In case the participant behaves inappropriately, the organization can exclude the student from further participation and place the student on the blacklist.
23. The participant is obliged to participate at the following parts of the event: the opening plenary session, the company case or the speeddates & company fair, the lunch, the closing session, the networking drink, and the recruitment dinner. When the participant does not attend all parts without any valid reason, the organization is allowed to place the participant on the blacklist and give him or her a fine of €70,-, in words seventy euro. Illness without medical certificate or connection loss without statement from your internet provider will not be accepted as valid reasons.
24. If the LED, due to any circumstances, needs to be scaled down, the LED cannot guarantee that everyone who purchased a ticket, can attend the LED 2023.
25. If the LED, due to any circumstances, needs to be held online, your ticket is still valid. You are obliged to participate in the day program of this online event, even if you have purchased a ticket for the physical event. However, the LOES cannot guarantee that everyone who has purchased a ticket, can participate in the online event.
26. If necessary, you are obligated to show a valid COVID-19 QR code. If you are not able to show this QR code, you cannot participate in the LED 2023 and you will be given a fine of €70,-, in words seventy euro, see section 23.
27. For section 21, 22, and 23, the organization of the LED 2023 is allowed to determine the validity of the reason given for cancellation of participation.

C2. Obligations students on the waiting list

28. Cancellation of a position on the waiting list of the LED 2023 without any valid reason is possible until Sunday December 11, 2022, 23.59 hours.
29. Before Monday January 9, 2023 23.59 hours, the students on the waiting list will be contacted. At that moment, they can decide to be placed on the definitive waiting list by informing the organization. In case a student is placed on the definitive waiting list, they are expected to be available on Thursday February 9, 2023 and can be called up for participation at the LED 2023 until Wednesday February 8, 11.59 hours at the latest. If students do not want to be put on the definitive waiting list, they will be excluded from participation at the LED 2023.
30. Cancellation of a position on the definitive waiting list without any valid reason after Monday January 16, 2023 23.59 hours will result in a fine of €30,-, in words thirty euro.
31. For section 28 and 30, the organization of the LED 2023 is allowed to determine the validity of the reason given for cancellation of a position on the (definitive) waiting list.

D. Blacklist

32. Students who are placed on the blacklist, will be informed personally. They will be excluded from participation in any events which are organized by the LOES for the next five years.
33. There is no opportunity to discuss the blacklist.
34. The blacklist is only available for the boards of the study associations who belong to the LOES and the board of the LED, and will thus not be published.
35. If a student is on the blacklist of their study association at the time of their registration for the LED 2023, the corresponding study association will remove the student from the selection and they will be informed of this by the LED board itself with the reasons for not being permitted to participate.

E. Obligations of the organization

36. The organization is obligated to provide a lunch, drinks, and a dinner during the LED 2023, in case of a physical LED.

F. Privacy statement

37. The LED 2023 adheres at all time to relevant laws and regulations, among which the Algemene Verordening Gegevensbescherming (AVG) / General Data Protection Regulation (GDPR).
38. Processing your personal data is limited to only the data that is necessary for the purposes for which they are provided.
39. We have taken appropriate technical and organizational measures to guarantee the security of your personal data.
40. No personal data will be passed on to third parties, unless this is necessary for executing the purposes for which they are provided.
41. We are aware of your rights regarding your personal data. We will point them out to you and respect them.
42. Personal data of applicants and participants are processed by the LED for the following purposes:
- Administrative purposes;
 - Providing information
43. Basis for the personal data:
- The participation registration form
44. For the above mentioned purposes, the LED can ask you for the following personal data:
- Name;
 - Address;
 - Postal Code;
 - Residence;
 - Phone number;
 - E-mail address;
 - Date of birth;
 - Bank data;
 - Study data (such as the association one is member of and the phase of the study one is in);
 - Preferences regarding the event itself (such as company preferences)
 - Optionally any other speciality (e.g. allergies) that you want the organization to know
45. We are aware that some specialities are qualified as special personal data. These will be treated with care and only for this particular event.
46. At the LED, screen recordings and/or screenshots can be made by the board or a photographer. By registering for the LED, you allow the organization to place these screen recordings and/or screenshots of you on the website. You have the right to demand those screen recordings and/or screenshots to be taken down.
47. Your personal data will be saved by the LED for the above mentioned purposes for the following time:
- The time between registration and the event, and after that in the administration for a maximum of five years.
48. The LOES cannot be held responsible for any consequences caused by faulty information details given by the participant.
